## IARC Reclassifies MOCA as Group I Carcinogen

The International Agency for Research on Cancer ("IARC") recently reclassified 4,4'-methylenebis (2-chloroaniline) ("MOCA") as "carcinogenic to humans" (Group 1) from its previous classification of "probably carcinogenic to humans" (Group 2A). The IARC has not yet published its official justification for the reclassification, but news release on the IARC website indicates that the reclassification was made based on "mechanistic and other relevant data" reviewed by the IARC.

A review of the British medical journal The Lancet revealed that the IARC considered data from four recent studies in making its determination. Interestingly, it does not appear that any of these studies conclusively demonstrate that MOCA causes cancer in humans. Rather, these studies purport to show only that MOCA causes damage to

human DNA. The IARC used this evidence, in combination with previously available studies that have documented that exposure to MOCA causes tumors in laboratory animals, as well as in-vitro tests that have shown that MOCA causes damage to DNA, to conclude that it had enough evidence to classify MOCA as a Group 1 carcinogen.

The PMA will be closely monitoring the actions of U.S. regulatory agencies in response to this reclassification. Thus far, the PMA is unaware of any pending U.S. reclassifications. However, in the event of any such efforts, the PMA will alert members of any opportunities to provide comment.
